Notice is hereby given that on Tuesday the 10th day of May 2022 at the designated polling places of election precincts of Saline County, Nebraska, an election will be held. The polls will open at 8:00 a.m. and close at 8:00 p.m. Said election will be for nominating candidates to various offices. Some races will not appear on the Primary Election ballot as the number of candidate filing does not exceed twice the number of vacancies; these candidates are declared nominated and advance to the November 8, 2022 General Election. Voters living in school districts that cross county lines will be voting on candidates and special issues in their respective districts.
