SALINE COUNTY BOARD OF EQUALIZATION

The regular meeting of the Saline County Board of Equalization opened with the Pledge of Allegiance. The meeting was called to order at 9:18 a.m. on Tuesday, April 16, 2019, by Chairperson, Marvin A. Kohout. Present were Janet J. Henning, Stephanie A. Krivohlavek, Kohout, Philip S. Hardenburger and Russ Karpisek, Commissioners, Administrative Assistant Tim McDermott, County Assessor Brandi Kelly and County Clerk Daryl Fikar

Notice of said meeting was posted in the County Clerk’s office, on the Saline County Website, and published in all county newspapers prior to the meeting, in compliance with State Statutes.

Kohout advised those present of the open meetings law posted at the back of the room.

County Assessor, Brandi Kelly presented tax list correction #2019-01, correcting a clerical error on a 2018 personal property schedule. After the tax statements were printed and sent, the Assessor’s Office was notified that the property owners had released their interest as of 9/22/2018. Henning moved to approve the correction, seconded by Karpisek. Voting aye were Kohout, Hardenburger, Krivohlavek, Henning and Karpisek, nays none, motion carried.

Kelly then presented tax list correction #2019-02, correcting a clerical error on a 2018 personal property schedule. After the tax statements were printed and sent, the Assessor’s Office was notified that the property owners had released their interest as of 9/22/2018. This correction transfers the taxes on the property to the new owners. Henning moved to approve the correction, seconded by Krivohlavek. Voting aye were Krivohlavek, Henning, Karpisek, Kohout and Hardenburger, nays none, motion carried.
