SALINE COUNTY BOARD OF EQUALIZATION

The regular meeting of the Saline County Board of Equalization opened with the Pledge of Allegiance. The meeting was called to order at 9:15 a.m. on Tuesday, September 14, 2021 by Vice Chairperson Philip Hardenburger. Present were Hardenburger, Stephanie A. Krivohlavek, Marvin A. Kohout, and Janet J. Henning, Commissioners and County Clerk Anita K. Bartels. Commissioner Russ Karpisek was absent.

Notice of said meeting was posted in the County Clerk's office, on the Saline County Website, and published in all three county newspapers on September 8, 2021, in compliance with State Statutes.

Hardenburger advised those present of the open meetings act posted at the back of the room.

Krivohlavek moved to approve the agenda as presented, seconded by Henning. Voting aye were Kohout, Krivohlavek, Hardenburger, and Henning, nays none, motion carried.

Henning moved to open the public hearing for vehicle exemptions, seconded by Krivohlavek. Voting aye were Krivohlavek, Henning, Hardenburger and Kohout, nays none, motion carried.

County Treasurer Debbie Spanyers presented an Application for Exemption submitted by the Crete Area Medical Center for a 2019 Honda CR-V, 2001 GMC Savana G2500, 2021 Chevrolet Silverado K2500 Heavy Duty pickup and 2018 Ford Transit Connect. These vehicles are used exclusively to support the work of the hospital.

Kohout moved to close the public hearing for vehicle exemptions, seconded by Henning. Voting aye were Henning, Kohout, Krivohlavek and Hardenburger, nays none, motion carried.

Krivohlavek moved to approve the Application for the Exemption submitted by the Crete Area Medical Center for four vehicles, seconded by Kohout. Voting aye were Kohout, Krivohlavek, Hardenburger and Henning, nays none, motion carried.
